WHEREAS, this purchase will be off the NPPGov Contract for Emergency Services and the price is lower than the price it could be purchased though the Florida Sheriffs, Florida Fire Chiefs and the Florida Association of Counties State Contract; and

NOW, THEREFORE, BE IT RESOLVED by the Commission of the City of Waycross that a contract be awarded to Ten 8 Fire & Safety of Bradenton, Florida, for the purchase of a new 2021 Pierce Saber Fire Pumper in an amount not to exceed \$484,852.00, and to be paid from budgeted Fire Department funds.

BE IT FURTHER RESOLVED that the Mayor, City Manager (or her designee), City Clerk, City Finance Director and City Attorney be authorized and directed to execute the Contract on behalf of the City of Waycross, and to do all the acts and things necessary in order to carry out the purposes and intent of this Resolution.
