

MINUTES
WAYCROSS CITY COMMISSION MEETING
TUESDAY, DECEMBER 3, 2019
5:00 PM

The Honorable John Knox, Mayor of the City of Waycross called the Regular City Commission Meeting to order on Tuesday, December 3, 2019 at the Commission Chambers of City Hall. Commissioners in attendance with Mayor John Knox were Mayor Pro Tem Diane Hopkins, Marian Solomon-Gaines, John Threat, and John Tindall. City Attorney Rick Currie and City Manager Tonya Miller were also in attendance. Commissioner Norman Davis was not present.

Commissioner Marian Solomon-Gaines introduced Community Improvement Director Marc Hawkins, who offered the opening invocation. The Invocation was followed by the Pledge of Allegiance led by Mayor John Knox.
